Dear Keeneyville District 20 Families,

We are pleased to share with our families that the required period for isolation of symptomatic and positive COVID-19 cases and the quarantine period for close contacts will be reduced to 5 days, starting on Tuesday, 1/18/2022. Please note that any students or staff that are impacted by isolation or quarantine as of 1/18 will be contacted with a new return to school date. Contact your school nurse with any questions regarding when your child is approved to return to school.

All extracurricular activities and after school athletic practices will also resume on Tuesday, 1/18, for elementary and middle school students. Athletic games will continue to be on pause until further notice.

District 20's Revised COVID-19 Protocols align with the recent guidelines and information released by the <u>Centers</u> for Disease Control and Prevention (CDC), <u>Illinois Executive Order 2022-03</u>, <u>Illinois Department of Health (IDPH) & Illinois State Board of Education (ISBE) Joint Guidance</u>, and <u>DuPage County Health Department (DCHD)</u>. Our top priority is still the health and safety of our students and staff and we will implement our layered mitigation approach to enable us to continue to provide in-person learning in a safe way. The D20 COVID-19 Protocols including universal masking, physical distancing, enhanced hygiene and cleaning practices will remain in place at this time. As a reminder, District 20 offers <u>free</u>, <u>quick</u>, <u>and easy COVID-19 testing</u> at school to keep our learning environment safe and help keep your child in school as much as possible. <u>Register for D20 COVID-19 Testing</u>.

### **DISTRICT 20 COVID-19 PROTOCOL UPDATES**

### **Isolation of POSITIVE CASES**

If you test positive for COVID-19, regardless of vaccination status, students and staff **must stay home and isolate for** 5 **calendar days.** To calculate the length of isolation, day 0 is the first day of symptoms or the specimen collection date (if no symptoms are present) and the isolation period runs from day 1 through day 5. **May return to school on** day 6 **if the following requirements are met:** 

- 1) Must be fever-free and no vomiting/diarrhea for 24 hours and other symptoms have improved. If symptoms are still present and have not improved after 5 days, the student/staff should wait to end isolation (and do not come to school) until they are fever-free and no vomiting/diarrhea for 24 hours and other symptoms have improved.
- 2) Must continue to wear well-fitted mask around others, including at home for 5 additional days after isolation. If unable to wear a mask when around others, they must continue to isolate for a total of 10 days.

### **Isolation of SYMPTOMATIC CASES**

If you have one or more of the <u>COVID-19 symptoms</u>, regardless of vaccination status, students and staff must either (A) get tested and show proof of negative test **OR** (B) stay home and isolate for <u>5 days</u>:

A. Get tested and provide proof of negative COVID-19 test results (RT-PCR or NAAT testing only). Testing will continue be available at school before you are sent home sick, parents may register online for the complete <a href="D20 COVID-19 Testing Program">D20 COVID-19 Testing Program</a> or fill out a paper one-time consent form with the school nurse. May return to school, if the following requirements are met:

- 1) Must be fever-free and no vomiting/diarrhea for 24 hours and other symptoms have improved. If symptoms are still present and have not improved after negative result, the student/staff should wait to end isolation (and do not come to school) until they are fever-free and no vomiting/diarrhea for 24 hours and other symptoms have improved.
- 2) Must continue to wear well-fitted mask around others, including at home for 5 additional days after isolation. If unable to wear a mask when around others, they must isolate for a total of 10 days.

#### --OR--

- B. If you choose not to get tested, you stay home and isolate for <u>5</u> calendar days. To calculate the length of isolation, day 0 is the first day of symptoms or the specimen collection date (if no symptoms are present) and the isolation period runs from day 1 through day 5. May return to school on <u>day 6</u> if the following requirements are met:
  - 1) Must be fever-free and no vomiting/diarrhea for 24 hours and other symptoms have improved. If symptoms are still present and have not improved after 5 days, the student/staff should wait to end isolation (and do not come to school) until they are fever-free and no vomiting/diarrhea for 24 hours and other symptoms have improved.
  - 2) Must continue to wear well-fitted mask around others, including at home for 5 additional days after isolation. If unable to wear a mask when around others, they must continue to isolate for a total of 10 days.

## **Quarantine of CLOSE CONTACTS**

If you were exposed to someone with a positive COVID-19 case <u>and</u> have no <u>COVID-19 symptoms</u>, students and staff in one of the following groups <u>must</u> either (A) participate in the Test to Stay alternative (see below) OR (B) quarantine at home for 5 days:

- ✓ Students and staff who are not fully vaccinated (not completed the primary COVID-19 vaccine doses)
- ✓ Staff who have received the primary COVID-19 vaccine doses but have not received a booster dose when eligible ("unboosted")

**The following people are exempt from this requirement** (not required to Quarantine or complete Test to Stay)

- ✓ Students ages 5-17 years who completed the primary series of a COVID-19 vaccine
- ✓ Staff who have received all recommended COVID-19 vaccine doses, including boosters
- ✓ Students and staff who have tested positive for COVID-19 in the past 90 days from the date of exposure
- A. <u>Test to Stay (TTS) is an alternative to quarantine</u> for asymptomatic students and staff who were exposed to a positive case while at school, during the school day. The program does not apply to exposures outside of the school day (i.e., extracurricular activities) or household exposures.
  - 1) Test to stay combines contact tracing and serial testing to allow the close contact to remain in school in a safe way. Rapid antigen testing will be conducted in the school nurse's office using a gentle, anterior nasal swab, two times: (1) on the first day of close contact notification/TTS enrollment and (2) on day 5 after exposure. If the test results are negative, you may return to the classroom. If a positive result occurs or symptoms begin, you will be immediately isolated and sent home to follow the above protocols.
  - 2) Parents and Staff must opt-in to the Test to Stay program by registering online for the D20 COVID-19 Testing Program. If you have previously registered online for the D20 COVID-19 Testing Program you have already consented to Test to Stay (if you choose not to participate in Test to Stay contact your school nurse to let them know).

#### --OR--

**B.** <u>If you choose not to participate in Test to Stay, you must stay home and quarantine for 5 calendar days.</u>

To calculate the length of quarantine, day 0 is the last day of contact with the positive case and the

quarantine period runs from day 1 through day 5. May return to school on <u>day 6</u> if the following requirements are met:

- **1) Must remain asymptomatic.** If one or more <u>COVID-19 symptom</u> arise, you must isolate at home and follow the above protocols for Symptomatic Cases.
- 2) Must continue to wear well-fitted mask around others, including at home for 5 additional days after isolation. If unable to wear a mask when around others, they should continue to isolate for a total of 10 days.

We know that there is a lot of information to digest with these revised COVID-19 Protocols. We will continue to keep you informed of any updates and will post the District's updated protocols on the website under the "Return to Learn" tab. We will continue to inform families of positive cases that were present in our school buildings on the D20 COVID-19 Dashboard.
