July 1, 2018 – October 31, 2018 (unaudited figures)

Education Fund – Received 85.16% of budgeted revenues or \$13.4 million. The Ed Fund expended 24% of budgeted dollars or \$3.8 million of budgeted dollars. Operations & Maintenance Fund – Received 82% of budgeted revenues or \$1.7 million of budgeted dollars and expended 28.3% or \$617,000 of budgeted dollars. Transportation Fund – Received 84% of budgeted revenues or \$715,000 and expended 16% of budgeted dollars or \$138,000 of budgeted dollars. Combined and all Funds – Received 76% of budgeted revenues or \$17 million and expended 30% or \$7 million.
