1.2 December Financial Dashboard

Mrs. Straub provided the Board of Education with the Financial Dashboard as follows: July 1, 2021 through November 30, 2021 (unaudited figures) Education Fund – Received 88.2% of budgeted revenuees or \$15.3 million. The Education Fund expneded 34% of budgetd dollars or \$5.9 million. Operations & Maintenance Fund – Received 55% of budgetd revenuese or \$1.9 million and expnded 62% or \$2.3 million of budgeted dollars. Transportation Fund – Received 105% of budgeted revenues or \$900,000 and expnded 32% or \$300,000 of budgeted dollars. Combined and All Funds – Received 84% of budgeted revenues or \$19.64 million and expnded 38% or \$8.95 million.
