Education Fund – Received 103% of budgeted revenues or \$17.1 million. The Ed Fund expended 78% of budgeted dollars or \$12.9 million .

Operations & Maintenance Fund – Received 100% of budgeted revenues or \$2.2 million and expended 62% or \$1.6 million of budgeted dollars.

Transportation Fund – Received 112% of budgeted revenues or \$1 million and expended 60% of budgeted dollars or \$567,000.

Combined and All Funds- Received 102% of budgeted revenues or \$22 million and expended 79% or \$20 million.
