Mrs. Straub provided the Board of Education with the Financial Dashboard as follows: July 1, 2021 through September 30, 2021 (unaudited figures) Education Fund – Received 77% of budgeted revenues or \$13 million. The Ed Fund expended 13% of budgeted dollars or \$3 million. Operations & Maintenance Fund – Received 53% of budgeted revenues or \$1.8 million and expended 34% or \$1.2 million of budgeted dollars. Transportation Fund – Received 93% of budgeted revenues or \$800,000 and expended 9% of budgeted dollars. Combined and All Funds- Received 75% of budgeted revenues or \$17.5 million and expended 22% or \$5 million.
