July 1, 2020 – October 31, 2020 (unaudited figures)

Education Fund – Received 80% of budgeted revenues or \$13.4 million. The Ed Fund expended 24% of budgeted dollars or \$4 million of budgeted dollars. Operations & Maintenance Fund – Received 90% of budgeted revenues or \$2 million and expended 19% or \$500,000 of budgeted dollars.

Transportation Fund – Received 93% of budgeted revenues or \$880,000 and expended 2% or \$23,000 of budgeted dollars.

Combined and all Funds – Received 83% of budgeted revenues or \$18 million and expended 34% or \$9 million of budgeted dollars.
