July 1, 2018 – November 30, 2018 (unaudited figures) Education Fund – Received 87.59% of budgeted revenues or \$13.8 million. The Ed Fund expended 33% of budgeted dollars or \$5.2 million of budgeted dollars.

Operations & Maintenance Fund – Received 82% of budgeted revenues or \$1.8 million of budgeted dollars and expended 34% or \$740,000 of budgeted dollars. Transportation Fund – Received 84% of budgeted revenues or \$720,000 and expended 26% of budgeted dollars or \$224,000 of budgeted dollars. Combined and all Funds – Received 78% of budgeted revenues or \$17.8 million and expended 38% or \$9 million.
